## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, half round band of 2.48mm width (at base) x 1.37mm depth, with open back settings, and supported with a curved underrail.

Feature one central white gold four claw railed setting, housing one round brilliant cut diamond, claw set. The central setting is secured between the extended 'ramp'style shoulders. Each shoulder housing four Princess cut diamonds, channel set.

Polished finish, stamped 'maple leaf symbol MHJ 18CT' - acid tested as 18 carat gold.

Finger size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "H".

Dimensions = 4.12mm(Dia) x 2.43mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity is "P1", colour is "H".

Dimensions = 1.80mm(L) x 1.80mm(W) x 1.28mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 4.20 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 4.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
