Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, 'dress' style ring, of hand-finished construction.

Plain, narrow, low half round band 2.45mm width (at base) x 0.65mm depth, with an open back setting.

Feature one central ten claw setting housing one old cut diamond, claw set. The extended shoulders are embellished with grooved detail. The gallery edge is embellished in a scalloped design.



Polished finish.

Stamped 'illegible makers mark 18' - acid tested as 18 carat gold. Assayed in Birmingham, England.

Ring size: T.

The ring contains:

One claw set old European cut diamond, clarity is "Vs", colour is "I".

Dimensions = 4.55mm(L) x 4.50mm(W) x 2.52mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 4.40 grams Total Gemstone Weight = 0.35ct Total Metal Weight = 4.33 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring using all modern round brilliant cut diamonds of the same estimated weight, colour and clarity employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
