Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-assembled raised, 18ct yellow and white gold, diamond set, cluster style ring. Plain, wide, low half round, tapered band, measures 4.94mm width (at base) x 0.83mm depth, with curved underrail.

Feature, "3pce ring set" fused together, forming one cluster style ring. a raised white gold four claw settings x five, contain five round brilliant cut diamonds, claw set. The extended shoulders, of the ring tapers up to the top, from both sides.

Polished finish, stamped "750, 18ct, 750" - acid tested as 18 carat gold. Finger size = N1/2.

The ring contains;

Five claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated) (smallest)

Dimensions = 2.30mm (average diameter) x 1.40mm (D-estimated) (largest)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 4.10 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 4.06 grams (estimated)

NOTE: Limited gemmological tested inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 3pce ring set fused as one ring. employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
