Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and platinum, diamond set, multistone ring, of hand finished construction.

Plain, narrow, low half round band of 2.00mm width (at base) x 1.10mm depth, with open back settings.

Feature central platinum four triple claw setting, housing one round brilliant cut diamond, claw set. Each of the shoulders have platinum shoulder plates, which are embellished with a 'leaf' design, and two single cut diamonds, bead set. Millegrain detail to the edges of the 'leaves'. The setting and shoulder plates are supported with chenier detail and secured to the top of the plain and polished yellow gold band.

Polished finish.

Stamped 'PLAT (partial) 18CT (partial)' - acid tested as 18 carat gold and platinum. Ring size: R 1/2.

The ring contains:

- One claw set round brilliant cut diamond, clarity is "P2", colour is "G".
Dimensions = 3.76mm(L) x 3.73mm(W) x 2.39mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.21ct (estimated - see NOTE below)
- Four bead set single cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).
Dimensions (average) = 1.30mm (diameter)
Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 2.18 grams Total Gemstone Weight = 0.25ct Total Metal Weight = 2.13 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
