Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 9ct yellow and white gold, diamond set, multistone ring. Plain, wide, flat, low half round, tapered band, measures 3.36mm width (at base) x 1.12mm depth, with curved underrail.

Feature: "solitaire style" ring design, with shoulder stones. Comprising, a raised u-shaped white gold, four claw setting to centre top. Houses one round brilliant cut diamond, claw set. The extended shoulders, of the yellow gold band, tapers up. Each shoulder having a square shaped setting, contains a square-shaped, faceted, diamond, bead set, both sides.

Polished finish, unstamped - acid tested as 9 carat gold.

Finger size = O.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Vs", colour is "H", medium cut quality.
Dimensions = 3.35mm (average diameter) x 2.25mm (D-estimated)
Total Weight = 0.15ct (estimated - see NOTE below).

Two bead set (square shaped), faceted, diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.
Average dimensions = 1.53mm (L) x 1.53mm (W) x 1.09mm (D-estimated)
Total Weight = 0.05ct (estimated - see NOTE below).

Total Item Weight = 2.96 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 2.92 grams, (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
