Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished raised, 18ct yellow gold & diamond set, multistone ring. Plain, wide, half round, tapered band, measures 3.04mm width (at base) x 0.83mm depth, with curved underrail, open back settings, underneath.

Feature; "graduating single row" style ring design. Comprising, five rub-over settings to top, tapering down. The extended shoulders, of the band taper up, with each terminating with three spheres grouped together. both sides.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = M1/2.

The ring contains;

Five rub over set round brilliant cut & single cut diamonds (mixed), clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.91mm (average diameter) x 1.17mm (D-estimated) (smallest)

Dimensions = 2.64mm (average diameter) x 1.61mm (D-estimated) (largest)

Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 3.86 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 3.82 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
