Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, 3pce set (fused as one), hand-assembled raised, 18ct yellow and white gold & diamond set, multistone ring. Plain, wide, flat, tapered band, measures 3.85mm width (at base) x 0.89mm depth, with curved underrail.

Feature; "3pce ring set" (fused together as one), Comprising, a raised white gold setting to centre, houses one round brilliant cut diamond, claw set. The extended shoulders, sweep up to the centre, terminate with three single cut diamonds, bead set both sides. Two plain outer bands (fused), creates the wide band.

Polished finish, stamped "18ct, 750, 5224C" - acid tested as 18 carat gold.

Finger size = R1/2.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.
Dimensions = 3.56mm (average diameter) x 2.17mm (D-estimated)
Total Weight = 0.16ct (estimated - see NOTE below).

Six bead set single cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.23mm (average diameter)
Total Weight = 0.06ct (estimated - see NOTE below).

Total Item Weight = 4.33 grams, Total Gemstone Weight = 0.22ct, Total Metal Weight = 4.29 grams, (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
