Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, diamond set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round band of 2.17mm width (at base) x 1.40mm depth, with hollow top and shoulders, and a cut out curved underrail.

Feature cushion shaped top plate, with a central illusion setting within four claw setting, housing one round brilliant cut diamond, illusion set. Surrounding is one floating row of round brilliant cut diamonds, bead set. The top plate is secured to the underrail, and in between the 'split' style shoulders. The gallery is embellished with one round brilliant cut diamond, bead set. Each of the shoulders has two rows of round brilliant cut diamonds, claw set. There are a total of fifty-six round brilliant cut diamonds. Millgrain detail to the edges.

Polished finish. Stamped '375 0.33' - acid tested as 9 carat gold. Ring size: M.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Si2", colour is "I".

Dimensions = 3.03mm(Dia) x 1.85mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.11ct (estimated - see NOTE below)

Fifty Six bead and claw set round brilliant cut diamonds, clarity is "Si", colour is "I to J" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.05mm(Dia) x 0.64mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.22ct (estimated - see NOTE below)

Total Item Weight = 2.57 grams Total Gemstone Weight = 0.33ct Total Metal Weight = 2.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
