Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.76mm width (at base) x 0.66mm depth, with open back (cut out) settings.

Feature rectangle top plate with one row of four round brilliant cut diamonds, slightly varying in size, and channel set. The settings are secured between the tapering shoulders of the plain and polished band.

Polished finish.

Stamped '750(engraved) illegible engraving' - acid tested as 18 carat gold.

Ring size: R.

The ring contains:

- Four channel set round brilliant cut diamonds, clarity is "Vs & Si1" (mixed), colour is "G to H" (mixed).
Dimensions = 2.84mm(Dia) x 1.73mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 2.98mm(Dia) x 1.82mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 4.29 grams

Total Gemstone Weight = 0.40ct

Total Metal Weight = 4.21 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
