Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and rhodium plated, diamond set, multistone, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.23mm width (at base) x 1.20mm depth, with open back settings.

Feature one row of five, four claw settings spanning across the top of the band, each housing one round brilliant cut diamond, graduating in size, largest to the centre, and claw set. There is a total of thirty-six round brilliant cut diamonds surrounding all of these central settings, claw set. Rhodium plating to the settings areas.

Polished finish. Unstamped - acid and x-rayed as approximately 9 carat gold. Ring size: S.

The ring contains:

Five claw set round brilliant cut diamonds, clarity is "P2 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 1.55mm(Dia) x 0.95mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.13ct (estimated - see NOTE below)

Thirty Six claw set round brilliant cut diamonds, clarity is "P1 & P3" (mixed), colour is "H to I" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.17ct (estimated - see NOTE below)

Total Item Weight = 2.07 grams Total Gemstone Weight = 0.30ct Total Metal Weight = 2.01 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
