## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct white gold and 9ct yellow gold, diamond set, decorative multistone ring, of hand-assembled construction.

Plain, wide band of 8.63mm width (at base) x 1.09mm depth, with open back settings.

Feature open double rail style yellow gold band. A white gold 'flower and leaf' design, within the bands. The design is set with a total of thirteen round brilliant cut diamonds, bezel and bead set. Millegrain detail to design edges.

Polished finish.

Stamped 'C 25 9K' - acid tested as 9 carat gold.

Ring size: L 1/2.

The ring contains:

- Six bezel and bead set round brilliant cut diamonds, clarity is "Si", colour is "I".
- Dimensions = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 1.65mm(Dia) x 1.01mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 4.78 grams  
Total Gemstone Weight = 0.10ct  
Total Metal Weight = 4.76 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
