Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct yellow gold & diamond set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band, measures 2.16mm width (at base) x 0.98mm depth, with curved underrail, open back settings, underneath.

Feature, "single channel row" style, runs across the top of the band. The extended shoulders, taper up wide to the top, from both sides.

Polished finish, stamped "750, JP88" - acid tested as 18 carat gold.

Finger size = M.

The ring contains;

Eleven channel set Princess cut diamonds, clarity is "Si", colour is "G to H" (mixed), medium cut quality.

Average dimensions = 2.40mm (L) x 2.00mm (W) x 1.78mm (D-estimated) (smallest)

Average dimensions = 2.30mm (L) x 2.25mm (W) x 1.60mm (D-estimated) (largest)

Total Weight = 0.75ct (estimated - see NOTE below).

Total Item Weight = 4.09 grams, Total Gemstone Weight = 0.75ct, Total Metal Weight = 3.94 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
