## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished, raised 18ct white gold & gemset, cluster ring. Plain, low half round, tapered band, measures 2.79mm width (at base) x 1.39mm depth, with underrail.

Feature, "cluster style" ring design, with shoulder stones. Comprising, a raised pear-shaped cluster to top, houses one pear-shaped lemon quartz, claw set. Drops to a diamond, beaded set surround. The extended shoulders, of the band, tapers up to the top, each shoulder terminates with a diamond, beaded set row, to both sides.

Polished finish, stamped "18K, 750" - acid tested as 18 carat gold. Finger size = M.

The ring contains;

One claw set pear-shaped, faceted natural lemon quartz, colour is "light, yellowish green".  
Dimensions = 12.35mm (L) x 8.03mm (W) x 5.37mm (D-estimated)  
Total Weight = 2.47ct (estimated - see NOTE below).

Forty Four bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.  
Dimensions = 0.98mm (average diameter) x 0.60mm (D-estimated)  
Total Weight = 0.18ct (estimated - see NOTE below).

Total Item Weight = 4.65 grams, Total Gemstone Weight = 2.65ct, Total Metal Weight = 4.12 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
