Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished, raised 18ct white gold & diamond set, ring, of cast construction. Plain, narrow, low half round, tapered band, measures 1.27mm width (at base) x 1.19mm depth, with curved underrail.

Feature. "solitaire style" with shoulder stones. Comprising, a raised four claw setting to top. The extended shoulders, of the band, tapers up to a filigree, pierced out shoulders & gallery walls. Each shoulder contains one single cut diamond, bead set, both sides.

Polished finish, stamped "18ct partial" - acid tested as 18 carat gold. Finger size = O1/2.

The ring contains;

One claw set Old European cut diamond, clarity is "P1", colour is "I", medium cut quality.

Dimensions = 5.04mm (diameter) x 2.85mm (D-estimated)

Total Weight = 0.44ct (estimated - see NOTE below).

Two bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "I", medium cut quality.

Dimensions = 1.35mm (average diameter)

Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 2.10 grams, Total Gemstone Weight = 0.46ct, Total Metal Weight = 2.01 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
