## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold, gemset, three stone ring. Plain, narrow, low half round, tapered band measures 1.36mm width (at base) x 1.30mm depth, with open back, settings, underneath.

Feature, Trilogy bridge style" ring design. Comprising, a raised trilogy square shaped settings to top, millgrane white gold tipped, illusion bead set. The extended shoulders, taper up to the top, each shoulder having a white gold motif, to both sides. Filligee peiced out work the the gallery side walls both sides.



Polished finish, stamped "18ct" - acid tested as 18 carat gold. Finger size = S.

the ring contains;

One illusion bead set round garnet glass doublet, colour is "medium dark - green".

Dimensions = 3.85mm (diameter) x 2.35mm (D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below).

Two illusion bead set Old European cut diamonds, clarity is "P1", colour is "H to I"(mixed), medium cut quality.

Dimensions = 3.08mm (average diameter) x 2.25mm (D-estimated)

Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 2.72 grams, Total Gemstone Weight = 0.32ct, Total Metal Weight = 2.66 grams (estimated)

NOTE: Limited gemmological testing, inset. The green stone is heavily included with bubbles, therfor ID as a garnet glass doublet, and woould need unsetting for full gemmological testing. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
