Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow gold & platinum, diamond set. three stone ring. Plain, narrow, low half round, tapered band, measures 1.78mm width (at base) x 1.07mm depth, underail.

Feature, "trilogy style" ring design. Comprising, a paltinum 3 x four claw setting to top, houses three Old European cut diamonds, claw set. The extended shoulders, og the band taper up with a platinum motif, to each side, pierced out filligree side walls, to undergallery, both sides.

Polished finish, stamped "18ct Plat" - acid tested.

Finger size = N1/2.

The ring contains;

Three claw set Old European cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 2.80mm (average diameter) x 1.82mm (D-estimated) (smallest)
Dimensions = 3.07mm (average diameter) x 1.72mm (D-estimated) (largest)
Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 2.36 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.30 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing, all modern brilliant cut diamonds, & similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
