### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, pair of lady's hand-assembled raised, 9ct rose gold & diamond set, hoop earrings.

Feature, "oval shaped hoop" earrings. Each comprising, a single row claw set to front. Hinged to base with a plain hollowed out clip to back.

Polished finish, stamped "9k" - acid tested as 9 carat gold.

Earring dimensions = 18.00mm (total length) x 2.03mm (width) x 2.22mm (depth).

The earrings contain:

Twenty claw set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 1.55mm (average diameter) x 0.95mm (D-estimated)

Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 2.39 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.33 grams (estimated)



NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar pair of hoop style earrings, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
