## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's hand finished raised, 18ct yellow gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 1.17mm width (at base) x 0.95mm depth, with curved underrail, open back settings, underneath.

Feature, Duo style ring design with shoulder side stones. Comprising, 2 x four claw railed settings to top. The extended shoulders, of the band, tapers up, splits, with a channel setting to one side.

Polished finish, stamped "18K" - acid tested as 18 carat gold. Finger size = M.

The ring contains;

Two claw set oval-shaped, natural tanzanites, colour is "medium light - violet/bluish". Average dimensions = 6.13mm (L) x 3.95mm (W) x 2.41mm (D-estimated) Total Weight = 0.82ct (estimated - see NOTE below).

Three channel set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.75mm (average diameter) x 1.07mm (D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below).

Total Item Weight = 4.43 grams, Total Gemstone Weight = 0.88ct, Total Metal Weight = 4.25 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
