Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, platinum & 18ct yellow gold, diamond set, ring.

Plain, narrow, low half round, parallel band, measures 3.01mm width (at base) x 2.09mm depth, with curved underrail.

Feature, "solitaire style" design. Comprising, a roll-over, yellow gold end setting to top. The extended shoulders, of the band, runs parallel to the top, from both sides.

Polished finish, stamped "Star PT 950" - acid tested & x-rayed.

Finger size = L1/2.

The ring contains;

One end set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 4.12mm (diameter) x 2.51mm (D-estimated)

Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 6.34 grams, Total Gemstone Weight = 0.26ct, Total Metal Weight = 6.29 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
