Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand finished raised 18ct yellow gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 2.43mm width (at base) x 0.77mm depth, with curved underrail, open back settings, underneath. Feature, "bridge style" ring design. Comprising, a five round brilliant cut diamonds to centre, flared to each side, one oval-shaped, faceted natural ruby claw set. The extended shoulders, of the band, tapers up to the top, terminates with one round brilliant cut diamond, claw set, both sides.



Polished finish, stamped "K18" - acid tested as 18 carat gold. Finger size = J.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 4.39mm (diameter) x 2.70mm (D-estimated)

Total Weight = 0.32ct (estimated - see NOTE below).

Two claw set oval-shaped natural rubies, colour is "medium dark - red".

Dimensions = 4.89mm (L) x 3.78mm (W) x 2.21mm (D-estimated)

Total Weight = 0.66ct (estimated - see NOTE below).

Six claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.

Dimensions = 1.54mm (average diameter) x 0.94mm (D-estimated) (smallest)

Dimensions = 1.86mm (average diameter) x 1.13mm (D-estimated) (largest)

Total Weight = 0.12ct (estimated - see NOTE below).

Total Item Weight = 3.43 grams, Total Gemstone Weight = 1.10ct, Total Metal Weight = 3.21 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
