Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 18ct white gold, gem set pendant.

Feature central four claw setting, housing one oval cut and faceted natural sapphire, claw set. Surrounded by two individual oval shape frames, claw set with a total of forty-seven round brilliant cut diamonds.

The bail assembly, also claw set with seven round brilliant cut diamonds.

Polished finish.

Stamped '750 RT S100' - acid tested as 18 carat gold.

Pendant dimensions = 22.46mm (length including bail) x 13.42mm (width).

The pendant contains:

One claw set mixed cut oval shape natural sapphire, colour 'dark blue'.

Dimensions = 6.39mm(L) x 5.39mm(W) x 3.08mm(D-estimated)

Total Weight = 1.00ct (estimated - see NOTE below)

Fifty Four claw set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'G to I' (mixed).

Dimensions (average) = 1.00mm(Dia) x 0.61mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.27ct (estimated - see NOTE below)

Total Item Weight = 2.07 grams - Total Gemstone Weight = 1.27ct - Total Metal Weight = 1.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
