## Valuation For Traditional Insurance Replacement Purposes

### Item 1

One, hand-assembled, 18ct white gold, multistone, gem set ring.

Plain, wide, low half round, tapered band of 3.20mm in width (at band) x 1.42mm in depth, with open setting backs.

Feature four 'corner' claw, 'solitaire' style railed setting, housing one Princess cut diamond, corner set.

The band having diamond set shoulders, each side channel set with five round brilliant cut diamonds.

Polished finish - stamped '18K' - acid tested to 18 carat gold. Finger size is O.

The ring contains:

One corner set Princess cut diamond, clarity 'Si2', colour 'G', very good cut quality.

Dimensions = 4.68mm(L) x 4.60mm(W) x 3.50mm(D-estimated) x 6%(Girdle Thickness)

Total Weight = 0.66ct (estimated - see NOTE below)

Ten channel set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'H to I' (mixed), medium cut quality.

Dimensions (average) = 1.50mm(Dia) x 0.86mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 5.10 grams - Total Gemstone Weight = 0.81ct - Total Metal Weight = 4.94 grams (estimated)

NOTE: The centre diamond has been certified by Messrs. Gemological Institute of America (GIA) laboratory Certificate number: 5136357988 Dated: May 18, 2012. The centre diamond has also been laser inscribed upon the girdle with GIA (logo) and 5136357988. Due to setting constraints, the exact dimensions of the shoulder gemstones cannot be ascertained. Therefore, weights of the shoulder gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the shoulder gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
