## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's, 2pce ring set, hand-finished raised, 18ct white gold & diamond set, multistone rings. Plain, narrow, low half round, tapered bands, measure a combined basal width 2.98mm x 0.81mm depth, with curved underrail.

Feature, "2pce ring set". Comprising, engagement ring, with trilogy setting to top, claw set. The extended shoulders, of the band, tapers up and splits to each side of the central setting. A complimenting, side band, contured to fit one side, having a single row across the top, with a twist, bead set. Polished finish, stamped "18K 750 MHJ.40,.10," - acid tested as 18 carat gold. Finger size = L1/2.



The ring set contains;

One claw set round brilliant cut diamond, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 3.70mm (Diameter) x 2.26mm (D-estimated)

Total Weight = 0.19ct (estimated - see NOTE below).

Two claw set round brilliant cut diamonds, clarity is "P2", colour is "H", medium cut quality.

Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated)

Total Weight = 0.06ct (estimated - see NOTE below).

Thirty Eight bead set round brilliant cut diamonds, clarity is "Si, P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 0.95mm (average diameter) x 0.58mm (D-estimated)

Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 4.66 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 4.56 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
