Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, raised 10ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.68mm width (at base) x 0.94mm depth, with curved underrail.

Feature, "duo claw setting" to top, houses two round brilliant cut diamonds, claw set. The extended shoulders, of the band tapers up to the top, each shoulder contains nine round brilliant cut & single cut diamonds, tapering sizes, claw set, both sides.

Polished finish, stamped "JS or SJ, 10K" - acid tested as approximately 10 carat gold

Finger size = N.



Two claw set round brilliant cut diamonds, clarity is "P3", colour is "H-I", medium cut quality.

Dimensions = 2.79mm(Dia) x 1.7mm(D-estimated) (smallest)

Dimensions = 2.86mm(Dia) x 1.74mm(D-estimated) (largest)

Total Weight = 0.16ct calculated

Eighteen claw set single cut & round brilliant cut diamonds (mixed), clarity is "P3", colour is "H to I"(mixed), medium cut quality.

Dimensions = 0.90mm (average diameter) (smallest)

Dimensions = 1.70mm (average diameter) (largest)

Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 2.20 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.14 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
