## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand finished, raised 14ct white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.94mm width (at base) x 1.08mm depth, with cut-out underrail, open back setting, underneath.

Feat raised six claw custer setting, to top. Houses seven round brilliant cut diamonds, illusion claw set (mixed). The extended shoulders, of the band, tapers up to the top, from both side.

Polished finish, stamped "585, CHRIST" - acid tested as 14 carat gold. Finger size = J1/2.

The ring contains;

One illusion set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 3.80mm (Diameter) x 2.14mm (D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below).

Six claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.30mm (average diameter) x 1.40mm (D-estimated) (smallest)

Dimensions = 2.40mm (average diameter) x 1.46mm (D-estimated) (largest)

Total Weight = 0.30ct (estimated - see NOTE below).

Total Item Weight = 3.30 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 3.20 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
