Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, half round band of 1.93mm width (at base) x 1.20mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central white gold round top plate, within a six claw setting. The top plate houses ten round brilliant cut diamonds, largest to the centre, claw set. Surrounding is one row of round brilliant cut diamonds, claw set. The setting is secured to the underrail, and in between the extended shoulders, of the plain and polished yellow gold band.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Si1", colour is "I".
Dimensions = 2.90mm(Dia) x 1.77mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.10ct (estimated - see NOTE below)

Nine claw set round brilliant cut diamonds, clarity is "Si", colour is "H to J" (mixed).
Dimensions (average) = 1.10mm(Dia) x 0.67mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 2.01 grams Total Gemstone Weight = 0.16ct Total Metal Weight = 1.98 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
