Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct yellow gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction. Plain, narrow, low half round, tapered band of 1.91mm width (at base) x 1.27mm depth, with a hollow top and shoulders, open back settings, and a cut out underrail.

Feature central rectangle top plate, housing two baguette cut diamonds, to the centre, claw set. Surrounding is one row of round brilliant cut diamonds, bead set. Either side of the central setting, is one rectangle top plate, housing one baguette cut diamond, to the centre, claw set. Surrounding is one row of round brilliant cut diamonds, bead set. The top plates are supported with a decorative pierced underrail, and one row of round brilliant cut diamonds, slightly graduating in size, bead set. Each of the shoulders houses one row of round brilliant cut diamonds, graduating in size, bead set. There are a total of sixty-six round brilliant cut diamonds.

Polished finish. Stamped '10K MHJ' - acid tested as 9 carat gold. Ring size: R 1/2.

The ring contains:

Four claw set baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "G".

Dimensions = 3.20mm(L) x 1.35mm(W) x 0.99mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 4.29mm(L) x 1.24mm(W) x 0.91mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.06ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G to H" (mixed).

Dimensions = 1.86mm(Dia) x 1.13mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.36mm(Dia) x 0.83mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.14ct (estimated - see NOTE below)

Fifty Eight claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.13mm(Dia) x 0.69mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.35ct (estimated - see NOTE below)

Total Item Weight = 3.23 grams Total Gemstone Weight = 0.55ct Total Metal Weight = 3.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
