Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, diamond set, 'dress' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.07mm width (at base) x 0.85mm depth, with a hollow top and shoulders.

Feature double octagonal top plate with a diamond shape recessed area in the centre. In the recessed area is a four claw setting, housing one round brilliant cut diamond, claw set. The top plate is secured between the tapering shoulders of the plain and polished band.

Polished finish.

Unstamped - acid tested as 9 carat gold.

Ring size: Q.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G".
Dimensions = 3.94mm(Dia) x 2.40mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.23ct (estimated - see NOTE below)

Total Item Weight = 4.87 grams
Total Gemstone Weight = 0.23ct
Total Metal Weight = 4.82 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
