Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.96mm in width (at base) x 1.19mm depth, with hollow top and shoulders, and open back settings.

Feature central four 'corner' claw setting, housing four round brilliant cut diamonds, claw set. Each raised shoulder section having six round brilliant cut diamonds, tapering in size, channel set.

Polished finish - stamped '375 JP88' - acid tested as 9 carat gold. Finger size is Q.

The ring contains:

Four claw set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'I to J' (mixed).
Dimensions (average) = 2.80mm(Dia) x 1.71mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.34ct (estimated - see NOTE below)

Twelve channel set round brilliant cut diamonds, clarity 'Si & P1' (mixed), colour 'H to J' (mixed).
Dimensions = 1.3mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)
Dimensions = 1.7mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness) (largest)
Total Weight = 0.16ct estimated

Total Item Weight = 3.58 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 3.48grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
