Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring.

Plain, narrow, tapered band of 1.88mm in width (at base) x 1.05mm depth, with cut-out open back settings, and hollow shoulders.

Feature central four 'corner' claw setting, housing four round brilliant cut diamonds (largest), claw set. Secured between the shoulders of the plain and polished band. Each shoulder having six round brilliant cut diamonds, tapering in size, channel set.

Polished finish.

Stamped '375 JP88' - acid tested as 9 carat gold.

Finger size is N.

The ring contains:

- Fourteen claw set & channel set (mixed) round brilliant cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'brown tint'.
- Dimensions = 1.50mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 2.60mm(Dia) x 1.56mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 3.31 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 3.21 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
