## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 14ct white gold, multistone, gem set ring, of cast construction. Plain, narrow, tapered band of 2.20mm in width (at base) x 1.06mm depth, with open back (cut-out) shoulders sections.

Feature 'cross-over' style semi-bezel setting, housing one Princess cut diamond, end set. Each shoulder having four Princess cut diamonds, tapering in size, channel set.

Polished finish - stamped '585 michael hill H39327 1.45' - acid tested as 14 carat gold. Finger size is K.



### The ring contains:

One end set Princess cut diamond, clarity 'P1', colour 'H'.

Dimensions = 5.01mm(L) x 4.96mm(W) x 4.06mm(D-estimated) x 7.7%(Girdle Thickness)

Total Weight = 0.95ct (known weight - see NOTE below)

Eight channel set Princess cut diamonds, clarity 'Si & P1' (mixed), colour 'H'.

Dimensions = 2.10mm(L) x 2.10mm(W) x 1.35mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.25mm(L) x 2.25mm(W) x 1.45mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.98 grams - Total Gemstone Weight = 1.45ct - Total Metal Weight = 4.69 grams (estimated)

NOTE: The centre diamond has been certified by Messrs. Australian Diamond Grading Laboratory (ADGL) Certificate number: H39327 Dated: 05/06/2013. The centre diamond has also been laser inscribed upon the girdle with ADGL (logo) michael hill and H39327. Due to setting constraints, the exact dimensions of the shoulder diamonds cannot be ascertained. Therefore, weights of the shoulder diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the shoulder diamonds require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
