Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, raised 18ct yellow gold & diamond set, multistone ring, of cast construction. Plain, narrow, low half round, tapered band, measures, 1.86mm width (at base) x 0.97mm depth, with open back, settings underneath.

Feature, "trilogy style" ring design, with shoulder stones. Comprising, a raised three rub-over settings, to top, housing three round brilliant cut diamonds, rub-over set. The extended shoulders, of the band, each side contains four round brilliant cut diamonds, channel set.

Polished finish, stamped "18K" - acid tested as 18 carat gold. Finger size = O.



The ring contains;

Three rub-over set round brilliant cut diamonds, clarity is "Si", colour is "H"(inset), medium cut quality.

Dimensions = 2.71mm (average diameter) x 1.72mm (D-estimated) (smallest)

Dimensions = 3.29mm (average diameter) x 2.18mm (D-estimated) (largest)

Total Weight = 0.30ct (estimated - see NOTE below).

Eight channel set round brilliant cut diamonds, clarity is "Si", colour is "H"(inset), medium cut quality.

Dimensions = 1.48mm (average diameter) x 0.90mm (D-estimated)

Total Weight = 0.10ct (estimated - see NOTE below).

Total Item Weight = 3.38 grams, Total Gemstone Weight = 0.40ct, Total Metal Weight = 3.30 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
