valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, dress style, gem set ring, of cast construction.

Plain, wide band of 5.04mm in width (at base) x 1.39mm depth, with open back settings.

Feature raised setting section to the centre top of the plain and polished band, housing one round brilliant cut diamond (largest), bead set. To the lower section is three round brilliant cut diamonds, also bead set, in a diagonal style.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is V.

The ring contains:

One bead set round brilliant cut diamond, clarity 'Vs', colour 'G'.

Dimensions = 4.00mm(Dia) x 2.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Three bead set round brilliant cut diamonds, clarity 'Vs' (mixed), colour 'G'.

Dimensions (average) = 1.50mm(Dia) x 0.92mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.05ct (estimated - see NOTE below)

Total Item Weight = 7.96 grams - Total Gemstone Weight = 0.28ct - Total Metal Weight = 7.90 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
