Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.40mm in width (at base) x 1.44mm depth, with open back (cut-out) shoulder settings.

Feature semi-bezel setting, housing one Princess cut diamond, end set. Each shoulder having four Princess cut diamonds, slightly tapering in size, channel set.

Polished finish - stamped '750 MHJ .50' - acid tested as 18 carat gold. Finger size is K.



The ring contains:

One end set Princess cut diamond, clarity 'Si', colour 'I'.

Dimensions = 3.35mm(L) x 3.34mm(W) x 2.55mm(D-estimated) x 4%(Girdle Thickness)

Total Weight = 0.27ct (estimated - see NOTE below)

Eight channel set Princess cut diamonds, clarity 'Si', colour 'H to I' (mixed).

Dimensions (average) = 1.65mm(L) x 1.63mm(W) x 1.05mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.23ct (estimated - see NOTE below)

Total Item Weight = 4.44 grams - Total Gemstone Weight = 0.50ct - Total Metal Weight = 4.34 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
