Twenty Eight bead set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "G to I" (mixed).

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)
