### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand-assembled raised, 18ct yellow and white gold & diamond set, multistone ring.

Plain, wide, low half round, tapered band, measures 4.79mm width (at base) x 0.77mm depth, with open back, underneath.

Feature, "square-shaped cluster" style ring design. Comprising, a white gold plate to top, houses twelve round brilliant cut diamond, bead set, in a grid style layout. The extended shoulders, of the yellow gold band, tapers up wide to the top, from both sides.

Polished finish, stamped "\*2869 AL 750" - acid tested as 18 carat gold.

Finger size = S.

The ring contains;

Twelve bead set round brilliant cut diamonds, clarity is "Vs & Si"(mixed), colour is "G to H"(mixed), medium cut quality.  
Dimensions = 2.00mm (average diameter) x 1.22mm (D-estimated)  
Total Weight = 0.36ct (estimated - see NOTE below).

Total Item Weight = 12.17 grams, Total Gemstone Weight = 0.36ct, Total Metal Weight = 12.10 grams, (estimated)

NOTE: Limited gemmological testing inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
