Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'solitaire' style ring, of cast construction.

Plain, narrow, low half round band of 1.56mm width (at base) x 1.18mm depth.

Feature central four claw setting, housing one synthetic laboratory grown diamond, claw set. The setting is secured between the shoulders of the plain and polished band.

Polished finish.

Stamped '14K michael hill LGD 22282515' - acid tested as 14 carat gold.

Ring size: M 1/2.

The ring contains:

One claw set round brilliant cut synthetic laboratory grown diamond, clarity is "Si1", colour is "K".
Dimensions = 5.31mm(L) x 5.29mm(W) x 3.21mm(D-estimated) x 4.1%(Girdle Thickness)
Total Weight = 0.55ct (known weight - see NOTE below)

Total Item Weight = 2.08 grams

Total Gemstone Weight = 0.55ct

Total Metal Weight = 1.97 grams (estimated)

NOTE: The synthetic laboratory grown diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. LG22282515 Dated June 13, 2022. The synthetic laboratory grown diamond has also been laser inscribed upon the girdle with IGI (logo) and LABGROWN LG22282515. Due to setting constraints, the exact dimensions of the synthetic laboratory grown diamond cannot be ascertained. Therefore, weight of the synthetic laboratory grown diamond is very much an estimation. For an accurate weight, colour, and clarity grading, the synthetic laboratory grown diamond requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
