Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, gemset, cluster ring. Plain, narrow, low half round, tapered band, measures 2.66mm width (at base) x 0.75mm depth, with curved underrail.

Feature, "custer style" ring design. Comprising, a raised white gold, four claw setting, to top. Drops to a wire basket surround, claw set. The extended shoulders, of the yellow gold band, tapers wide to the top, each shoulder having a swept up arrow head feature to both sides on top.



Polished finish, stamped "18ct Pall/Plat" - acid tested as 18 carat gold. Finger size = T

The ring contains;

One claw set oval-shaped synthetic sapphire, colour is "medium dark - pink".
Dimensions = 8.37mm (L) x 6.76mm (W) x 4.00mm (D-estimated)
Total Weight = 1.83ct (estimated - see NOTE below).

Fourteen claw set single cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.40mm (average diameter) (smallest)
Dimensions = 1.60mm (average diameter) (largest)
Total Weight = 0.21ct (estimated - see NOTE below).

Total Item Weight = 6.75 grams, Total Gemstone Weight = 2.04ct, Total Metal Weight = 6.34 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
