## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's, hand finished, raised 14ct white gold & gemset, multistone ring.

Plain, narrow, low half round, tapered band, measures 1.30mm width (at base) x 0.95mm depth, with curved underrail, open back setting, underneath.

Feature, "solitaire style", with shoulder stones. Comprising, a raised four claw setting to top, houses one round, faceted, synthetic moissanite stone, claw set. The extended shoulders, of the band tapers up, each shoulder contains, eight round, faceted, cubic zirconia, claw set, both sides.



Polished finish, stamped "14K D1.0ct, 6156484999" - acid tested as 14 carat gold.

Finger size = S1/2.

The ring contains;

One claw set round synthetic moissanite, colour is "colourless".

Dimensions = 6.55mm (average diameter) x 3.93mm (D-estimated)

Total Weight = 1.00ct (estimated - see NOTE below).

Sixteen claw set round cubic zirconias, colour is "colourless".

Dimensions = 1.35mm (average diameter) x 0.82mm (D-estimated)

Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 1.54 grams, Total Gemstone Weight = 1.26ct, Total Metal Weight = 1.29 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
