Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled 18ct yellow gold & gemset, flexible link necklet.

Feature, "drop, style cluster" necklet. Comprising, a twenty seven, large oval-shaped, hollowed links, alternate with twenty seven smaller oval-shaped, hollowed links. To the bottom center, a circular-shaped doughnut, rhodium plated, houses ninteen round brilliant cut diamonds, bead set. Suspended from below the doughnut, a pendulum octagon-shaped, open centre, with nail head features to top, plain cut out pattern underneath, back. Housing one hundred & ninteen round brilliant cut diamonds, bead set, rhodium plated to highlight. Necklet secured with an 18 carat white gold, hinged clip clasp attached.



Polished finish, stamped "750, Sepahan" - acid tested as 18 carat gold.

Necklet dimensions = 43.00cm (L) x 8.25mm (W) x 2.53mm (depth).

The necklet contains:

One Hundred And Thirty Eight bead set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "G to I"(mixed), medium cut quality.

Dimensions = 1.40mm (average diameter) x 0.85mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 2.00ct (estimated - see NOTE below).

Total Item Weight = 57.30 grams, Total Gemstone Weight = 2.00ct, Total Metal Weight = 56.90 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar necklet employing similar materials and techniques being for a retail insurance purpose only.
