Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & gemset, multistone ring. Plain, wide, flat, tapered band, measures 3.30mm width (at base) x 0.84mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising, a raised white gold, navette shaped cluster setting to top, houses thirteen round brilliant cut diamonds, claw set. The extended shoulders, of the yellow gold band, tapers up to the top, from both sides.

Polished finish, stamped "18ct Pall" - acid tested as 18 carat gold.

Finger size = N.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 4.45mm (average diameter) x 2.71mm (D-estimated)
Total Weight = 0.33ct (estimated - see NOTE below).

Twelve claw set round brilliant cut diamonds, clarity is "Vs & Si (mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 2.30mm (average diameter) x 1.40mm (D-estimated) (smallest)
Dimensions = 3.00mm (average diameter) x 1.83mm (D-estimated) (largest)
Total Weight = 1.07ct (estimated - see NOTE below).

Total Item Weight = 6.62 grams, Total Gemstone Weight = 1.40ct, Total Metal Weight = 6.34 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
