Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand crafted, 18ct white gold, multistone, gem set ring.

Plain, narrow, low half round, tapered band of 2.67mm in width (at base) x 1.40mm depth, with open back settings.

Feature central four claw wide railed settings, housing one emerald cut diamond, claw set. The setting secured in the top of the plain and polished band. Each shoulder having two baguette cut diamonds, rub-over set.

Polished finish - stamped '750' - acid tested as 18 carat gold. Finger size is J.

The ring contains:

One claw set emerald cut diamond, clarity 'Vs', colour 'G'.

Dimensions = 4.84mm(L) x 3.37mm(W) x 2.40mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.38ct (estimated - see NOTE below)

Four rub over set baguette cut diamonds, clarity 'Vs', colour 'G/H'.

Dimensions = 2.64mm(L) x 1.60mm(W) x 1.05mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 5.00 grams - Total Gemstone Weight = 0.58ct - Total Metal Weight = 4.89 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
