Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 18ct yellow gold & gemstone set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.19mm width (at base) x 0.99mm depth, with curved underrail.

Feature, "cluster style" ring design, Comprising, a raised cultured pear to centre, drops to a surround, housing, sixteen round brilliant cut diamonds, tapering sizes, claw set. The extended shoulders of the band, tapers up to pointed end terminations, both sides.

Polished finish, stamped "750 36-317" - acid tested as 18 carat gold. Finger size = L

The ring contains;

One end-drilled semi-round cultured white/pink pearl, lustre is "Medium", blemish is "Lightly spotted".
Dimensions = 8.98mm (Diameter) x 8.98mm (depth).
(estimated - see NOTE below).

Sixteen claw set round brilliant cut diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.
Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (smallest)
Dimensions = 1.74mm (average diameter) x 1.06mm (D-estimated) (largest)
Total Weight = 0.25ct (estimated - see NOTE below).

Total Item Weight = 4.60 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 4.55 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
