Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, diamond set, solitaire ring. Plain, wide, flat, low half round, tapered band, measures 3.25mm width (at base), x 0.99mm depth, with a v-shaped, under rail.

Feature, "solitaire style" ring design. Comprising, a raised white gold claw setting, to centre top, houses one round brilliant cut diamond, illusion claw set. The extended shoulders, of the band tapers up with an upswept wire on top, each side.

Polished finish, stamped "18CT, (sheild P)" - acid tested as 18 carat gold.

Finger size = M.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "Si2", colour is "H", medium cut quality.

Dimensions = 3.40mm (Diameter) x 2.07mm (D-estimated)

Total Weight = 0.15ct (estimated - see NOTE below).

Total Item Weight = 4.50 grams, Total Gemstone Weight = 0.15ct, Total Metal Weight = 4.47 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
