Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and rhodium plated, multistone, gem set ring, of cast construction.

Plain, narrow, half round band of 2.38mm in width (at base) x 0.88mm depth, with hollow top and shoulders, and open back settings.

Feature central semi bezel setting, housing one round brilliant cut diamond, semi rub-over set. To either side is one pear-shape natural sapphires, semi rub-over set. Secured between the shoulders of the plain and polished band.

Polished finish - stamped '750' - acid tested as 18 carat gold.

The ring contains:

One semi rub-over set round brilliant cut diamond, clarity 'Si', colour 'G'.
Dimensions = 3.25mm(Dia) x 1.99mm(D-estimated) x 2%(Girdle Thickness)
Total Weight = 0.13ct (estimated - see NOTE below)

Two semi rub-over set mixed cut pear-shape natural sapphires, colour 'medium dark blue'.
Dimensions (average) = 4.00mm(L) x 2.98mm(W) x 1.80mm(D-estimated)
Total Weight = 0.30ct (estimated - see NOTE below)

Total Item Weight = 3.27 grams - Total Gemstone Weight = 0.43ct - Total Metal Weight = 3.18 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
