## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, platinum, diamond set pendant, of cast construction.

Feature central three 'double' claw setting, housing one round brilliant cut diamond, claw set. Secured between the flourish pendant design.

The top forming the hidden bail assembly.

Polished finish.

Stamped 'Pt950 D015ct' - acid tested.

Pendant dimensions = 21.30mm (length) x 10.34mm (width).

The pendant contains:

One claw set round brilliant cut diamond, clarity 'Vs', colour 'I'.

Dimensions = 3.35mm(Dia) x 2.04mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Total Item Weight = 0.15 grams

Total Gemstone Weight = 0.15ct

Total Metal Weight = 0.12 grams (estimated)



NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
