Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, diamond set, multistone ring. Plain, narrow, flat, low half round, tapered band, measures, 2.10mm width (at base) x 0.89mm depth, with curved underrail.

Feature, "solitaire style" with shoulder stones. Comprising, a raised six claw setting of white gold, houses one round brilliant cut diamond, claw set. The extended shoulders, of the band, taper up, each shoulder having a ribbon motif, contains three single cut diamonds, bead set, both sides.

Polished finish, stamped "18CT BEV" - acid tested as 18 carat gold. Finger size = L.

the ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.
Dimensions = 4.56mm (Diameter) x 2.78mm (D-estimated)
Total Weight = 0.37ct (estimated - see NOTE below).

Six bead set single cut diamonds, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 1.20mm (average diameter) (smallest)
Dimensions = 1.40mm (average diameter) (largest)
Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 2.50 grams, Total Gemstone Weight = 0.45ct, Total Metal Weight = 2.41 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
