Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished raised, 18ct white gold & gemstone set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.83mm width (at base) x 1.26mm depth, with curved underrail.

Feature, "cross-over ribbon design". Comprising, a raised six claw setting to centre top, houses one round faceted, natural sapphire, claw set. The extended shoulders, of the band, tapers up to a cross-over ribbon design, from both sides, containing twenty four round brilliant cut diamonds, claw set.



Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = O.

the ring contains;

One claw set round, faceted, natural sapphire, colour is "medium blue".
Dimensions = 4.11mm (Diameter) x 2.47mm (D-estimated)
Total Weight = 0.30ct (estimated - see NOTE below).

Twenty Four claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.
Dimensions = 1.33mm (average diameter) x 0.81mm (D-estimated)
Total Weight = 0.24ct (estimated - see NOTE below).

Total Item Weight = 5.90 grams, Total Gemstone Weight = 0.54ct, Total Metal Weight = 5.79 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
