Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand-assembled raised, 18ct white gold & geamstone set, cluster style pendant.

Feature, "cluster style" drop pendant. Comprising, a raised four claw setting to centre. Drops to a wire basket surround, claw set. The Pendant is suspended from a fixed v-shaped bail attached to top.

Polished finish, unstamped - acid tested as 18 carat gold.

Pendant dimensions = 28.45 mm (L) x 14.54 mm (W) x 10.90 (D).

The pendant contains:

One claw set oval shaped carnelian cabochon cut, colour is "dark red".

Dimensions = 11.40mm (L) x 7.48mm (W) x 5.54mm (D-estimated)

Total Weight = 3.27ct (estimated - see NOTE below).

Twelve claw set round brilliant cut diamonds, clarity is "Si", colour is "K to L"(mixed), medium cut quality.

Dimensions = 2.49mm (average diameter) x 1.52mm (D-estimated)

Total Weight = 0.70ct (estimated - see NOTE below).

Total Item Weight = 3.95 grams, Total Gemstone Weight = 3.97ct, Total Metal Weight = 3.16 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
