## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand-assembled raised, 18ct white gold & gemstone set, flexible link necklet.

Feature, "drop style cluster" pendant. Comprising, a raised cluster setting to centre, housing, eleven round brilliant cut diamonds, mixed with five oval cut, faceted natural sapphires, all claw set. Drops to an open surround, containing, twenty round brilliant cut diamonds, claw set. open to back underneath. an articulated v-shaped, bail attached to top. Suspended from a fine box style link chain, with a parrot clasp closure.



Polished finish, stamped "750, Trust (ingraving) & Asian symbols" - acid tetsed as 18 carat gold.

Necklet dimensions = 46.00cm (total length inclusive) x 1.00mm (width) x 1.00mm (depth).  
Pendant dimensons = 23.00mm (length) x 16.31mm (width) x 6.65mm (depth).

The necklet/pendant contains:

Five claw set oval-cut, faceted, natural sapphires, colour is "medium dark blue".  
Average dimensions = 4.00mm (L) x 2.88mm (W) x 1.91mm (D-estimated)  
Total Weight = 0.90ct (estimated - see NOTE below).

Thirty One claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.  
Dimensions = 1.28mm (average diameter) x 0.78mm (D-estimated) (smallest)  
Dimensions = 1.60mm (average diameter) x 0.98mm (D-estimated) (largest)  
Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 7.34 grams, Total Gemstone Weight = 1.30ct, Total Metal Weight = 7.08 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar necklet/pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
